



IMPORTANT NOTES

THESE ARE STANDARD, GENERIC AND NOT SITE SPECIFIC FITTING INSTRUCTIONS FOR LIFTING FAST FORM WALL SYSTEM

REMOVE BOLTS CONNECTING INTERMEDIATE BRACES TO UPRIGHTS, IN PLACES WHERE THE LIFTING ATTACHMENT IS GOING TO BE USED (IN THIS EXAMPLE, CIRCLED IN RED)

FIX LIFTING ATTACHMENTS TO UPRIGHTS LOCATED EITHER SIDE OF THE CENTRAL UPRIGHT - REFER TO [LIFTING ATTACHMENT FIXING DETAIL FOR INSTALLATION OF LIFTING ATTACHMENT AND LIFTING EYE.

IF MI6 SWIVEL LIFTING EYE (SALE ITEM ONLY) SUPPLIED BY FAST FORM SYSTEM THESE WILL INCLUDE A VALID CERTIFICATE OF TEST.

STEP 3

FIX WALER BEAMS, MAKING SURE THE TOP WALER BEAM IS FIXED DIRECTLY UNDERNEATH THE LIFTING ATTACHMENT. FIX BOTTOM WALER BEAM DIRECTLY ABOVE BOTTOM ROW OF INTERMEDIATE BRACES, MAKING SURE BOTH BEAMS ARE FIXED CENTRALLY TO THE PANEL. REFER TO [WALER BEAM FIXING DETAIL] FOR INSTALLATION OF WALER BEAMS.






PLYWOOD FIXING ARRANGEMENT FOR LIFTING PANELS
